

At this time there are no reference standards available for (+)48-THC is a different compound from the main (-)48-THC cannabinoid and, therefore, these two compounds may have different efficacies. Using the most advanced instruments and teachingues available, the separation of (+)48-THC and d9-THC is problematic for the scientific community as a whole.
